## SUBSTANCE FREE HOUSING AGREEMENT

A substance-free environment is defined as one where the following is prohibited: all use of tobacco (including hookah, e-cigs, pipes, cigars and cigarettes), use and possession of cannabis, use and possession of alcohol, use of illegal drugs or the misuse/abuse of prescription drugs. Additionally, neither residents nor their guests may return to the environment under the influence of any of the aforementioned substances.

Residents who request placement in substance-free housing agree to the following standards:

- 1. The use or possession of alcohol and illegal drugs is not permitted within the community. This applies to all areas of the substance free community including, but not limited to: personal rooms, hallways, bathrooms, lounges and stairwells.
- 2. Residents may not enter the house under the influence of alcohol or other drugs. Problematic behavior that results from residents being under the influence of alcohol or other drugs (eg: floor damages, vomiting, public intoxication, fighting or other policy violations) are also prohibited. Such behaviors will be processed via conduct and failure to abide by this agreement may result in an additional conduct charge and/or be considered as an aggravating factor in sanctioning.
- 3. Residents are responsible for guest behavior and assume accountability for their guests. It is the responsibility of the resident to ensure that guests are both aware of and comply with policies outlined in the Student Conduct Code, Residential Expectations and this agreement.
- 4. Residents are responsible for supporting the substance free community. This includes expressing concerns to fellow students/residents who are not in compliance with the agreement and community expectations and also sharing their concerns with staff (the Community Advisor or Residence Director).
- 5. Violations of the Substance Free Housing Agreement will be handled as follows:
  - a. An incident report will be generated and the individual(s) involved will have the opportunity to meet with a professional staff member, per the conduct protocol.
  - b. Additionally, the Department of Residential Education and Housing may consider a violation of this agreement to be a breach of contract and may reassign the individual to another space (space permitting). In such instances, there is no guarantee of an equitable space.
  - c. In the event a student is removed from housing, any housing refund would be issued in accordance with the College's refund policies.

I have read, understand and agree to abide by the terms and conditions of this Substance Free Housing Agreement for the duration of my residency in the Substance Free House. I may terminate my agreement by moving to other College housing that is not designated as a Substance Free Environment. I understand to change my room assignment, I need to do so by meeting with Housing or my Residence Director. If no other appropriate space is available, I agree to abide by this agreement and these guidelines until such time as I can relocate and move to other housing assignment at the College. I understand that violation of this agreement may result in administrative of conduct action which may include a reassignment to other College housing or removal from College housing altogether.
